- I should be able to announce the PE teacher, Mrs. Lambert's replacement, new 4th grade teacher, and other switches going on at OLOL
- I am still working with GRACE on some other staffing that I would like to do.

Furniture Update

- Must have \$4,440 for cubbies and hooks on the 2nd level
- Must have \$1,705 for three additional science table for science
- Must have \$6,672.88 for 4 additional round cafeteria tables
- We have a total of about \$93,000 (\$80,000 for TSF and \$13,000 general restricted) to spend. That will leave
 a balance of \$3,000)
- We will have about \$82,000 for regular classroom furniture upgrades
- I will determine what each room has to spend and then work with the teachers on standing desks and tables.

SCRIP research and window blinds

- Mrs. Ashauer and Mr. Young report
 - SCRIP
 - In past it was divided up between school, faith formation, and youth ministry
 - Currently, 68 school families (77%) 20 faith formation families 23%
 - Next step: need to form a group to decide how to spend current funds and meet annually going forward.
 - o Shades
 - Tammy is our point person for shades. She researched 4 different vendors
 - Father Jim is looking for something similar to what is in the church. Screen shade with roller on top and continuous loops for moving up and down. Will block light, but allow you to see out.
 - 55 windows (2 shades per window)
 - We will go through Julien Shades Shop (Bryan Julien) out of West Bend.
 - Shades in by Aug 11 & 22
 - SCRIP funds will cover blinds
